DIGEST

Protest alleging bidding improprieties is denied. Touchstone Forest Products' (TFP) letter of protest is included by reference. [Attachment 1]

AUTHORITY

The Chief Procurement Officer¹ (CPO) conducted an administrative review pursuant to S.C. Code Ann. §11-35-4210(4). This decision is based on materials in the procurement file and applicable law and precedents.

ANALYSIS

The University of South Carolina (USC) issued this Invitation For Bids (IFB) on January 16, 2018, for double hammered hardwood mulch delivered to various locations at the University of South Carolina Columbia Campus. The solicitation required bid to be submitted by 11:00 AM on February 20, 2018. Regulation 19-445.2090(B) requires that the award date be published in the solicitation:

The procurement officer shall issue the notice of intent to award or award on the date specified in the solicitation, unless the procurement officer determines, and gives notice, that a longer review time is necessary. The procurement officer shall give notice of a time extension to each bidder by posting it at the location identified in the solicitation.

(emphasis added)

In accordance with Regulation 19-445.2090(B) the first page of the solicitation specified that the award would be made on February 27, 2018. [Attachment 2] Amendment 1 was issued on January 23, 2018. Bids were received on February 20, 2018. Bids were time and date stamped at the time of bid opening. On February 27, 2018, in compliance with Regulation 19-445.2090(B), the procurement officer issued an Extension of Award Posting Date setting a new award date of March 6, 2018. [Attachment 3] An Intent to Award was posted to State Tree Service, LLC on March 6, 2018.

On March 9, 2018, TFP protested:

I am writing this letter to formally protest the awarding of the contract for bid USC-IFB-3247(double hammered hardwood mulch), as I firmly believe that at the time of the original bid submission deadline, my company had submitted the lowest fulfillment bid. Subsequent to the seemingly random extension of the bid deadline, I believe another bid was placed for exactly fifty cents less per cubic yard, which seems wildly unlikely in a sealed bid scenario.

The bid tabulation indicates that it was prepared on February 20, 2018. [Attachment 4] The bid tabulation indicates that State Tree Service, LLC submitted a bid of \$11.00 per ton and Touchstone submitted a bid of \$11.50 per ton for the mulch. The two bids were time and date stamped at bid opening and both indicate they were received at 11:00 AM on February 20, 2018. [Attachments 5 and 6] There is nothing in the record to indicate that the bid of State Tree Service was received after original bid submission deadline. The burden of proof is on the protestant to demonstrate by a preponderance of the evidence that there were improprieties in the solicitation process. TFP failed to meet its burden of proof.

DECISION

For the reasons stated above, the protest of Touchstone Forest Products, Inc. is denied.

Protest Appeal Notice (Revised July 2017)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.
