The following questions were submitted in writing by Vendor A. (Answers follow.)

RFP Section 2.1; paragraph 5

1. Should the State Health Plan move to non-grandfathered status and the administrator incurs additional cost as a result of implementing these requirements (programmatic changes, etc.), should the all-inclusive fee reflect and include costs associated with such changes, or will the State Health Plan allow the Offeror to request additional administrative fee changes or cost reimbursements as a result of any changes required to administer the new plan at the time of implementation?

A: The all-inclusive fee must reflect and include costs associated with such changes.

- 2. Does PEBA require a certain percentage of non-key personnel (including contractors, claims and customer service staff) to be within 100 miles of PEBA's offices? If so, please provide the percentage.
