Cyber Liability Costs Rise

Cyber-attacks and data breaches are expensive for government agencies. The average cost of a data breach in 2021 was \$9.05 million, up nearly 5% since 2020. Ransomware attacks cost an average of \$4.62 million.

Cyber insurance policies are developed to address the impacts from cyber incidents and mitigate damages if a data breach or ransomware attack occurs.

The Office of State Procurement awarded a contract for broker services for cyber insurance to Willis of North Carolina in December 2018. The contract is only available for use by State Agencies. Willis will assess and advise agencies on data breach or cyber liability insurance needs, including breach event response and other available services; will advise on how to structure a program; will obtain detailed proposals, including price quotes, from insurers for Cyber insurance, and present the proposals to agencies for acceptance or rejection.

The insurance will cover first- and third-party risks related to unlawful electronic security breaches, fraud, financial loss, reputational damage, regulatory intervention, and other causes of loss. Services expected to be provided include, but are not limited to breach event response, crisis management, and other available services. Agencies will complete the application for cyber liability insurance and submit the application to Willis. Willis will assist the agency with finalizing the application, send the application to the insurance market for quotes, and provide the quotes to the agency. Representatives from Willis will also schedule inperson and/or web-based meetings to answer any questions an agency may have about the coverage options and conduct additional negotiations on behalf of the agency if necessary. Willis will assist with binding coverage and issuing the policy should the agency decide to purchase cyber insurance. Other services that Willis can provide are educational seminars concerning cyber breach avoidance and recovery, assistance in developing an incident response plan, and coverage gap analysis to help an agency determine where their exposure lies.

NASPO Small Package Delivery Services (December Update)

NASPO has completed negotiations with UPS and is creating a new Master Agreement as of this writing. We are actively monitoring the situation, both with NASPO and the lead State, and will negotiate a participating addendum once the Master Agreement is awarded. Until, then the FedEx contract is active and available for use.

Vehicle Contracts (December Update)

We continue to see some issues with ordering windows closing with little to no warning from the manufacturers. We'll keep the vehicle contract sheets updated with the best information we have, but we strongly recommend contacting the Contractor for the vehicle you are interested in ordering **BEFORE** you submit a purchase order. They'll have the latest information from the manufacturer and can advise you on whether an order can be placed.

Product Category Code Issue – Laboratory Equipment, Chemicals & Supplies

It has been brought to our attention that the NIGP product category code used to create the lab equipment contracts (97952) is causing some issues for users. That product category is defined by NIGP as "Laboratory Equipment and Accessory Rental or Lease: For General and Analytical Research Use, Nuclear, Optical, Physical." However, when we look at the definition of that category code on the contract in SCEIS, it says "Laboratory Equipment and Accessories: General Use."

The issue is that the 97952 code defaults to some general ledger lines for leasing lab equipment, which is not the intention or purpose of this contract. The new contracts will begin on April 1, 2022, and what we'll do is use the product category code 49000 which is "Laboratory Equipment and Accessories (For General Analytical and Research Use): Nuclear, Optical, and Physical" to alleviate the issue. Until that time, you'll need to ensure that the proper GL account line appears on any purchase orders processed against those contracts.

STC Deliverable-Based IT Consulting & Professional Services

Additionally, we've added two requirements affecting Job Orders. The second is that UGUs must receive Job Order Quotes from at least two Contractors (non-responses, letters indicating no response, and the like don't count!) in order to proceed with a Job Order.
