COVID-19-Specific Issues

REUSABLE CLOTH MASKS AVAILABLE ON MULTIPLE STCs

Cloth masks, both antibacterial/antimicrobial and regular, are available on multiple already established STCs. Most contracts that provide access to a Contractor's entire catalog may have masks available as many vendors are beginning to offer those products. Some specific examples of Contractors who are offering cloth face masks are:

Fastenal (MRO)
Grainger (MRO)
MSC (MRO)
Staples (Office Supply)
Products Unlimited (Medical Supplies)

NOTE: Be very careful when looking for antibacterial/antimicrobial reusable face masks. Some manufacturers use metals (silver/copper) or pesticides (Silvadur) on their masks to create the antibacterial/antimicrobial effect, and those could pose hazards to some users. Some of these masks utilize bamboo because it has a natural antibacterial/antimicrobial effect. However, some users may be allergic to bamboo.

DESKTOP DIVIDERS/BARRIERS

Many of the manufactures on the STC for furniture are now offering transparent and non-transparent dividers for use on tables and desks for COVID-19 protection. As the list is ever changing as new manufacturers begin offering these items, our contract sheet does not specify manufacturers doing so.

Check with the manufacturer you are working with to inquire if these items are available.

SPECIAL NOTICES

Vehicle Rental Services – It is widely known that on May 22, 2020, Hertz filed for bankruptcy protection under Chapter 11 of the United States Code. The purpose of the filing was to provide Hertz protection from lawsuits while they reorganized their company and solidified their financial base as a result of the effects of COVID-19.

Almost all service locations in South Carolina remain open and fully operational so there will be minimal, if any, impact to their performance under the contract. The few servicing locations that have been closed were primarily located inside other types of businesses (airports, hotels, etc.) that had little to no actual customer use.

We are working with the supplier to ensure that no additional actions are necessary and will communicate through Dispatches if anything changes.

Dental Products Contracts – Due to some miscommunication with MMCAP, the dental products contracts for Darby Dental (4400010327) and Dental Health Products (4400010394) have expired. We are working with MMCAP to create new agreements with both of those of those vendors, but it may take a few weeks. The new dental products contract with Henry Schein (4400023352) is in effect with an expiration date of July 7, 2025. We will post a notice here when the other contracts are in place.

Lamps & Ballasts -- Border States Electric Supply is no longer using the Shealy Electric tradename. The Shealy Electric (VIN 7000247577) Lamps & Ballasts contract number 4400016974 has been replaced by Border States Electric (VIN 7000256472) contract number 4400024366. The change is effective as of July 20, 2020.

UVC LED Sanitizing Machine – The OSP is putting together a STC for the sanitization of equipment such as Laptops, Chromebooks. iPads, Smart Phones, etc. By the time you read this, the solicitation should already be published, but there is still time to make changes in an amendment. Educational Supplies – After significant research, the State will NOT be soliciting a separate contract for educational supplies. Most of the items that were identified as an "educational supply" are available under the existing STCs for office supplies. Other items not available on the office supply contracts are available, with generous discounts, from agreements by the South Carolina School District Consortium.

The following were identified as items to be considered for an educational supplies contract:

Educational Furniture
Education Materials
Manipulatives
Training Materials

As it pertains to Educational Furniture, current and long-standing statewide contracts provide for this specific segment of furniture to be supplied. Second, with regard to educational materials, these items were identified and classified as "Laminating film, spiral charts 16x24 and 24x32, and the roll craft paper," all of which are available via statewide contracts for Office Supplies & Copy Paper under the heading Art, Drafting and School Supplies. The contracts in place provide a discount for these

items at 60% or 65% off retail price. Third, manipulatives were described as "various objects or materials that students can use, touch, or move around in a classroom in order to help with learning concepts such as math, science, art etc." However, in further conversation it was discovered that manipulatives are grade and classroom specific and educators often use manipulatives which are classroom and lesson precise (differentiated) and are used to tailored to fit students with different strengths and weaknesses. Additionally, manipulatives are accompanied by additional training materials such as specified above.

Therefore, from a contracting perspective, manipulatives and training materials, while not specifically addressed in current statewide contracts, are commodities in which may be better left to those at the district level as the materials and need do not allow for a broad stroke approach to contracting, but rather requires technical specifications to fill specific and pointed need. Having said that, contracts are in place for Science Education Supplies that include a variety of educational materials and supplies that could be utilized in a similar fashion.

The contract offers the following services only:

Disinfection up to 10,000 SF- Price per square foot for electrostatic disinfection up to 10,000 SF

Disinfection 10,000-100,000 SF- Price per square foot for electrostatic disinfection between 10,000 SF up to 100,000 SF

Disinfection over 100,000 SF- Price per square foot for electrostatic disinfection for over 100,000 SF

Vehicle Flat Rate- Price per vehicle for electrostatic disinfection service

Bus Flat Rate- Price per bus (school bus, transit bus, etc.) for electrostatic disinfection service

Vehicle Discount Rate- Discount per vehicle for electrostatic disinfection service when coupled with facility disinfection services

Minimum charge to provide Services.

Detention Space Electrostatic Disinfection Service -- Price per square foot for electrostatic disinfection of Detention Space.

Any other disinfection services related to COVID-19 must be procured through your janitorial services provider or through the source selection methods under the procurement code.

It is the using governmental unit's responsibility to confirm the products that the Contractors are using meet the qualifications of the contract, including asking the Contractor to provide evidence to that affect, should there be any question.

Note: Some of these Contractors are new to the State's contracts and may be unfamiliar with our processes and procedures. Please be patient with those contractors and walk them through what they need to do to provide services.



New and Improved Statewide Temporary Personnel Service Contracts

A little birdy chirped in our ear and The South Carolina Division of Procurement Services (DPS) listened! In order to better serve all statewide contract end-users, as of June 15th, 2020, new Statewide Temporary Personnel Service contracts are in place. Contracted vendors are ready to meet your organization's temporary staffing needs.

With the old contracting period ending June 30, 2020, overlapping contracting periods aimed to provide Using Governmental Units (UGUs) a two-week opportunity to renew current relationships with temporary staffing providers, diversify relationships utilizing new vendors, and to align budget considerations with a new minimum/maximum pay structure.



You may be asking yourself, how does this work?



Cooperating with your organization's Hiring Managers or Human Resource department you can maintain the provided job descriptions and further refine a position description to meet your needs. For example your organization needs to temporarily hire a Clerical Specialist with procurement experience. Working within and maintaining the scope of job descriptions provided to you, your organization has the ability to customize and add individual sought-after skills. Of course the job description cannot be completely modified from a Clerical Specialist to an Accountant or Assistant Finance Director. UGUs must remain vigilant ensuring the scope of the provided job description is strictly adhered to. Secondly, once the position description is finalized, based on the pre-determined minimum and maximum pay structure for Clerical Specialist, your organization is authorized to pay no less than the minimum amount of \$9.35 per hour up to the maximum hourly rate of \$17.64 per hour. **Keep in mind, the rate ceiling applies to the rate before the markup is applied, so what is actually paid to the temp agency may be more than the range in the contract.** For example, the maximum pay rate for the Clerical Specialist is \$17.64 per hour. If an agency has a temp in at the max rate – they would actually be paying the contractor \$24.696 per hour (rate plus 40% markup).

Working within and maintaining the scope of the provided job descriptions is critical to avoiding contract misuse. On the other hand, to use the contract correctly, a UGU <u>may not</u> pay more than the maximum amount for any given job description. That said, a UGU is authorized to pay any amount between the minimum and maximum hourly rates of pay for a coordinating job description. This authorization allows UGUs to access temporary employees which best suit its individual hiring needs and pay accordingly considering a temporary employee's experience, skill level, and, perhaps, the cost of living (where applicable).

Note that the new contracts in place do not provide the framework for temporarily hiring <u>any</u> medical personnel, IT or executive-level incumbents. As it pertains to IT professionals and executive-level staff augmentation, there are other statewide contracts in place. UGUs wishing to contract for medical staffing MUST follow the SC Consolidated Procurement Code to obtain any skill level of temporary medical staffing.

The South Carolina Division of Procurement Services hopes it has set in place a more seamless transition from one contracting period into the next.
