Without proper planning, you WILL run out of fuel this winter

Unless you've been living under a rock or hibernating all year long, you're aware fuel prices, especially for diesel, are erratic at least and crazy at best. We'll not go into all of the different political, economic and logistical issues creating the situation. Suffice it to say there isn't much we can do about any of it because it's out of our control. What we *can* control is proper planning for fuel needs when things start to get even crazier.

No fuel is more essential to the global economy than diesel. In transportation it powers trucks, ships, buses, and trains. It powers construction, farming, and manufacturing machinery and it's used to heat homes.

Here are some of the issues that those who are paid to keep an eye on things have observed lately:

- · Increased cost of diesel amid shortages in supply
- Diversion of diesel to the Northeast for use as heating oil
- Terminals serving branded customers (Shell, BP, Chevron, etc.) before non-branded (our contractors), which causes...
- ...our contractors having to visit multiple terminals to get fuel to fulfill our orders, adding additional expenses
- More US diesel being shipped to European countries because of the Russian sanctions (that haven't kicked in yet)
 aiding the oil companies to make a better profit
- Strikes, like the averted rail strike, which could have a huge impact on fuel availability

Again, for those who are tuned into the market, none of this is a surprise, but it's putting additional strain on our fuel contractors and their ability to provide service. A few weeks ago, Mansfield Energy, the Contractor for our fuel card management system, moved the Southeast US into a "Red" status which means you need to order fuel 72 hours prior to your expected delivery, instead of the usual 24-hours.

Here are some tips to help keep you from an emergency situation for the coming months (and yes, assume it will be months).

- Plan ahead for everything You know your needs better than anyone and are most likely working with the same contractor(s) on a regular basis. Work with them to ensure smooth delivery of your orders, even if they need to deliver after hours, and maybe even pre-schedule deliveries if you're not doing so. There's nothing in the contract that restricts you from setting up recurring deliveries on a regular basis.
- Keep an eye on the weather—EVERYWHERE Weather has a huge impact on fuel availability, but not just the weather in South Carolina. Heavy snowstorms in Texas, Louisiana, and the Midwest can have an impact on the abil-

ity to get fuel into, out of, or through those regions which will impact the availability to get fuel to us. If it looks like a massive storm system is going to hit those parts of the country, make sure you're topped off ahead of time.

- Keep your tanks topped off Especially those of you who have contracts with your energy company where they can turn off your fuel when they need more assets for residential use. That can happen with little notice and you'll be stuck trying to get fuel on an emergency basis.
- Overreact ahead of time, not in the moment Play it safe and err on the side of caution as much as possible, because we are ALL going to experience a shortage at the same time. At some point there is going to be limited availability and we are all going to be competing for the same limited supply.

I'm not trying to be an alarmist, but the fuel situation is pretty rocky and you need to be prepared. SFAA DPS is working with our fuel Contractors as much as necessary on pricing, so keep an eye on the <u>fuel contract sheets</u> for updates or changes to pricing. We will communicate any alterations to contracted pricing on those sheets. Remember an ounce of prevention is worth a pound (or gallon) of cure.

NEW Athletic Uniform Contracts - DeAna Reed-Sharpe, NIGP-CPP (drsharpe@mmo.sc.gov)

The new statewide term contracts for athletic uniforms, equipment, and accessories went into effect November 17, 2022. These are non-mandatory statewide term contracts offering a catalog discount for various brands for the purchase of new athletic uniforms (stock and custom), PE wear, footwear, accessories, and small equipment used in the practice, performance, and participation in a specific sport. The discount is available via catalog and on-line ordering. Athletic wear and gear used by coaches and game officials are also included in this contract. We received offers from and awarded contracts to BSN Sports LLC, Johnson-Lambe Company Inc., and Shuma Sports. Awarded ven-



dors offered discounts for four categories of uniforms: Athletic Uniforms (stock), Custom Athletic Uniforms, Athletic Footwear and Athletic Equipment & Accessories. The contract information on the Procurement website includes a chart depicting the awarded vendors, their awarded brands, categories, and discounts. Embroidery and silk screen pricing is also included on our site. The solicitation contains subsequent evaluation and award periods. The number of available brands and vendors may increase as additional offers are received and evaluated during the contract term.

Large equipment used in training (i.e. football sleds, tackling dummies, etc.) and equipment normally associated with a gym (weights, machines, treadmills, etc.) are NOT included in this contract. We're working on a separate contract for that equipment and will be reaching out for your input very soon.

NEW Temporary Medical Staffing Contracts - Portia Davis (pdavis@mmo.sc.gov)

Due to the professional medical personnel shortage, the State has implemented a non-mandatory contract for <u>Temporary Medical Services</u>. This contract will help alleviate Using Governmental Units' (UGUs') staffing shortages until a permanent employee can be hired.

The medical staff positions are filled by Locum Tenens providers for positions including, but not limited to, Registered Nurses (RNs), Licensed Practical Nurses (LPNs), Licensed Baccalaureate Social Workers (LBSW), and Phlebotomists. Employees of Locum Tenens must be licensed by the State of South Carolina Board of Nursing, have a Multi-State License through the National Council of the State Boards of Nursing – Nurse Licensure Compact as a Registered Nurse, License Practical Nurse or hold current licensure by the State of South Carolina Board of Social Work Examiners.

The maximum markup the vendor can charge is 45% and the pay rates must be within the stated values listed on the contract. The Procurement Manager can add additional positions upon approval and proper documentation, so if there is a position you think should be added, contact Portia and provide her with:

- The position Title
- A detailed position description (use one of the contracts as an example)

A recommended hourly pay band with a minimum and maximum hourly rate, with a justification to support the recommended rates
