These contracts contain the best negotiated prices for Body Cameras, In Car Video and SaaS: Video Storage, Software and Data for you, without having to do the heavy lifting on your own. There were two Lots awarded as follows: Lot 1 – Body Camera and In – Car Video and SaaS; Video Storage, Software, and Data. Lot 2 – Body Camera Video System and SaaS: Video Storage and Data. We are happy to have awarded this contract to give our law enforcement partners a reliable avenue to purchase these increasingly important tools. 

### NEW STCs EFFECTIVE NOV. 1ST FOR MOST VEHICLE TYPES

\*\*CRITICAL DEADLINES MAY AFFECT YOUR LAW ENFORCEMENT PURCHASES

- ⇒ The 2020 model year order cut off for the Dodge Charger pursuit 5.7L AWD and 3.6L RWD (LE-4) is November 13, 2019. Orders received in the Chrysler Order System after this date, will not be considered for production.
- ⇒ Due to a delayed start-up time, it is encouraged that orders for the 2020 Police Interceptor Utility vehicles (LE-9) be placed to allow at least 6 months, from order to build, for Spring or Summer delivery in 2020. The Police Responder F- 150 and Police Responder Sedan (Fusion Platform) are still available until February of 2020 and F-150 orders will be accepted again in April of 2020.
