Flu Vaccine Contract Extensions

MMCAP has extended their master agreements for flu vaccine until July 31, 2025, while they continue to evaluate/negotiate new agreements. The current contracts expire April 30, 2025, so we will work with both FFF (4400023718) and McKesson (4400023717) to get their contracts extended to match the new MMCAP dates. You'll see those new dates reflected on the contract sheet once those updates are made.

All Type C&D School Bus Contracts

All the STCs for Type C&D school buses are expiring no later than May 12, 2025. The Department of Education is the driving force behind these contracts, and they are working on developing new specifications for the next solicitation. It's a process that is specified by law and requires different approvals to start the actual specifications meetings.

All that to say that it is our intent to let these contracts expire and resolicit later this year, probably around July-August timeframe, when the new specifications are approved. If your entity wishes to purchase a bus under any of the existing contracts, you need to reach out the appropriate procurement manager to have that conversation. I would caution you that I have serious doubts that any of the Contractors could hold their existing pricing because of the tariffs on steel coming in from other countries. Negotiations for a new price will be necessary if we try and extend them beyond the current expiration date, so plan for more than what current prices are.

Lightbars – Law Enforcement, EMS & Fire Department (Expires 2/8/2026) – DeAna Reed-Sharpe (**drsharpe@mmo.sc.gov**) is beginning her market research on this one, but since we did this last, NASPO awarded contracts for these products. NOTE: Please get this link to the people using the contract and ask them to do a comparison and give DeAna their thoughts on the pros and cons of participating in the NASPO contract rather than doing our own. Be advised that the existing NASPO contracts expired February 28, 2025, and NASPO is evaluating offers now.

14-Passenger Mini-Buses (Expires 2/21/2026) — Ginger Hardee (**gghardee@mmo.sc.gov**) will be working with the supplier community and SCDE to finalize the specifications on these buses. Please contract her if you have any special requirements that we need to consider during that process. **DID YOU KNOW...** because of Jacob's Law the contracts for 14-passenger mini-buses are open to NON-GOVERNEMNT entities in South Carolina? Jacob's Law says that any entity, **public or private**, transporting school age children to and from public or private school, daycare facilities and churches must use this type of vehicle. So, tell your churches and daycare facilities that these contracts are available to them and to contact Ginger Hardee if they have any questions.

Tasers (Expires 3/3/2026) – Ginger Hardee (ghardee@mmo.sc.gov) is beginning her market research into the next iteration of this contract. This is basically a sole source contract with Axon X2 and X26 tasers and accessories. This is NOT the Taser 7 contract published by the IT team. I have to say I'm impressed with the number of sales under this contract given that the Taser 7 has pretty much cornered

the taser market for law enforcement, but obviously there is still a demand for the Axon Taser 2 series devices. Please reach out to Ginger if you have any information that you feel will be helpful, or if your agency anticipates a shift to a different product or model.

Tires (Expires 3/28/2026) – Ginger Hardee (**gghardee@mmosc.gov**) is beginning her market research for the next solicitation. This is one of those that we are basically contracted with everyone for everything, but we still could use your input on anything you feel would be helpful. If something is missing or could be modified, please do not hesitate to share your ideas. We want to ensure all needs are incorporated and covered through this STC.

Biometric Time Keeping (Extended to 07/06/2026 or until a new solicitation is awarded-whichever comes first) – We anticipate publishing this solicitation October 2025. Cooperative Contracts Updates

Nationwide Vehicle and Large Truck Rentals – NASPO has awarded contracts to Enterprise and Hertz for the subject contracts. Negotiations continue with Enterprise while they are complete with Hertz. Once both Master Agreements are complete, we will review them with the intention of issuing a Participating Addendum for both suppliers.

All purchase orders must be closed out in SRM created prior to July 1, 2024.


Agencies have until July 14, 2025, to close out purchase orders in SRM Purchase Orders will be migrated from SRM to SCPro July 15, 2025.

Only purchase orders created after July 1, 2024, and remain open after July 14 will be migrated to SCPro.

Migrated purchase orders will receive a new SCPro PO number and will receive a new ECC PO number in the "47" series. The original ECC PO number will be referenced on the SCPro PO.




