### **REQUIRED MINIMUM SPECIFICATIONS FOR TRAILERS**

**Introduction:** The following are requirements for a 2,000 pound capacity trailer designed to transport a four (4) wheel all-terrain vehicle utilized by the S.C Department of Natural Resources.

**Specifications:** (Specifications must be compatible with ATV offered as Item #1).  
Compatibility should include tie downs, loading & unloading, key safety & efficiency features, etc.

**Frame:** Minimum 2 Inch x 2 Inch structural angle iron.

**Axle:** Minimum 2 Inch solid steel with easy lube axle. Rated at a minimum of 2,000 pounds.

**Leaf Springs:** Minimum four (4). Rated 1,000 pounds per wheel. Total capacity 1870 pounds.

**Fenders:** with Backs

**Tongue:** Shall be 3 Inch angle or 3 Inch channel, 2 safety chains with heated hook and 2 Inch coupler, tongue jack with 500 pounds capacity.

**Lighting:** Trailer shall be lighted to Department of Transportation requirements with a four way flat electrical plug for auto. Offerors should be certain that the lightning & wiring specifications of trailer tie into the ATV wiring system.

**Spare Tire:** Minimum 175/80 D13 (1,360 LB) with (Spare tire should be properly mounted to the front, side, or underneath the trailer as per industry standards)

**Tires:** Tires to be minimum 175/80 D13 (1,360 LB)

**Flooring:** 2 Inch treated wood and should be attached to and reinforced on all sides to include the proper frame reinforcement in the middle in order to prevent trailer bottom from moving up and down when manually loading ATV and walk on by human entry.

**Loading Gate:** 4 foot expanded metal ramp gate

**Rail:** Trailers to have a fifteen (15) inch railing around front, and the total length of the sides constructed

Tie Downs: Four (4) tie down loops

Color: Trailer to be completely primed on all surfaces and painted Black to include bottom on all metal surfaces.

Length: Eight (8) feet.

Width: Sixty (60) inches
