Notable Contract Terms:

Furniture Sales

Furniture sales may be purchased directly with Manufacturer or through an authorized dealer. Manufacturers have the sole responsibility for sales reporting.

- Authorized dealers MAY NOT propose to sell furniture for a manufacturer until they have received approval by the Procurement Officer.
- Authorized dealers will only be added twice/year. Manufacturers must request dealer additions on the appropriate form Page 50, Attachment A of [Amendment 8.pdf](#). Forms must be submitted to the Procurement Officer by the first Tuesday of June and December of each year.
- Manufacturers/Authorized dealers may not combine contract and non-contract items on the same quote.

Design Services

Design services, if available to the State user, may be accepted/approved at the sole discretion of the State user. Any design service fee shall be explicitly quoted prior to beginning work; however it is to the sole discretion of the entity whether it shall be ordered, invoiced, and paid on the same purchase order as the furniture order. Contractors shall not begin performance until receiving confirmation of mutual understanding of applicable expectations prior to beginning service.

Order Cancellation

The Using Governmental Unit may cancel an order without penalty within five (5) days after issuance and receipt of purchase order. The State will allow Contractor, at their option, to charge a State user a restocking fee for orders that are cancelled in excess of five (5) days after receipt of the purchase order.

Contractors must notify the customer prior to accepting the purchase order if the item is in stock or may shall ship within 30 days. In this instance ordering entity has three (3) calendar days to cancel the order without penalty. No "Quick ship" orders and/or special products may be cancelled after the order is scheduled for shipment.

Contractors may refuse cancellation or charge a penalty fee for furniture, which is built to order or customized according to the Using Governmental Unit's specification regarding shape, size, color, materials, fabric, finishes, designs, etc. Cancellation or penalty terms must be placed on the Contractor's quote and presented to Using Governmental Unit prior to issuance of purchase order.

Minimum Order, Ship Quantity, or Dollar Value

Contractor shall not impose, throughout the life of the contract, any minimum orders, ship quantities, or minimum dollar values to receive the minimum required discounts from list price.

Surcharges

No surcharges of any type can be applied by the Manufacturer to invoices for contract purchases. The State shall be reimbursed for any charges that were applied and erroneously paid by a State user.

Standard Delivery to State Users

Standard delivery of all goods at the offered Discount from Manufacturer's Current List Contract Price will be inside, and ready for use, unless otherwise stated on the State user's purchase order. [Please see Page 20 of Amendment 8 for more information regarding Delivery.](#)

Installation

Contractor shall install items acquired pursuant to this contract as follows:

Installation of products requiring custom or complex fitting due to the nature of the product shall be quoted, ordered and billed separately. Determination of **any** installation costs (complexity/custom installation) shall be made with the Using Governmental Unit prior to issuance of purchase order.

Acceptance and approval of **labor** for installation of such products will be at the sole discretion of the Using Governmental Unit. Any resulting damages to the product or State property during the installation by the Contractor will be repaired at the Contractor's expense and according to the warranty requirements of this contract.

Notes to Procurement Officers

1. Please confirm the following for your vendors:
 - Manufacturers are on contract to sell the items being quoted.
 - Authorized Representatives are ALREADY approved by the State Procurement Officer to sell on behalf of the contractor.
2. Delivery and installation are included in this contract. The only exception is for furniture extreme conditions (both defined on pages 20-21 of Amendment 8). In this case, the vendor must have prior written approval:
 - Delivery and/or installation must be stated on the vendor's quote.
 - Delivery and/or installation must be stated on the purchase order.
3. To assist in maintaining adequate record keeping, Procurement Officers are requested to place the name of the manufacturer and contract number on all purchase orders placed to Authorized Dealers.
