DIGEST

Protest alleging inappropriate application of preferences is denied as untimely. GFG Supply's (GFG) letter of protest is included by reference. (Attachment 1)

AUTHORITY

The Chief Procurement Officer¹ (CPO) conducted an administrative review pursuant to S.C. Code Ann. §11-35-4210(4). This decision is based on materials in the procurement file and applicable law and precedents.

¹ The Materials Management Officer delegated the administrative review of this protest to the Chief Procurement Officer for Information Technology.

BACKGROUND

Solicitation Issued	April 30, 2019
Intent to Award Posted	May 22, 2019
Protest Received	May 28, 2019

The South Carolina Department of Transportation (DOT) issued this Invitation for Bids for H Piles on April 30, 2019. Four bids were received. All four bidders applied for and received the benefit of the US manufactured preference authorized by Section 11-35-1524 of the Code. Taylor & Burns Coating also applied for and received the benefit of the resident vendor preference. An Intent to Award was posted to Taylor & Burns on May 22, 2019. GFG protests that, because the H Piles are used in construction and the preferences do not apply to supplies or services related to construction, the preferences should not have factored in the award to Taylor & Burns.

ANALYSIS

This Invitation for Bids was issued on April 30, 2019. Page 2 of the solicitation includes a description of the applicable preferences. As noted in the letter of protest, page 15 of the solicitation alerts bidders to the availability of the end-product and resident-vendor preferences. The bidding schedule found on page 28 of the solicitation requires bidders to indicate whether they are applying for the resident-vendor, South Carolina-made, or US-made preferences. In submitting its bid, GFG specifically declined the resident-vendor and South Carolina-made preferences and claimed the US-made preference. (Attachment 2)

Section 11-35-4210(1)(b) grants actual bidders, offerors, contractors or subcontractors the right to protest the award of a contract but stipulates that an issue that could have been raised as a protest of the solicitation, cannot be raised as a protest of the award:

Any actual bidder, offeror, contractor, or subcontractor who is aggrieved in connection with the intended award or award of a contract shall protest to the appropriate chief procurement officer in the manner stated in subsection (2)(b) within ten days of the date award or notification of intent to award, whichever is earlier, is posted in accordance with this code; except that a matter that could have

been raised pursuant to (a) as a protest of the solicitation may not be raised as a

protest of the award or intended award of a contract.

GFG was put on notice that the preferences would apply to this solicitation at the time the

solicitation. GFG's argument that "I assumed that these construction supplies (H PILES) should

be exempt from preference advantage and, thus, we participated accordingly," is a bit

disingenuous since its bid applied for the US-made preferences. GFG was aware of the

application of the preferences to this solicitation at the time the solicitation was issued and is

barred from raising that issue as a protest of the award. This issue of protest is denied.

DECISION

For the reasons stated above, the protest of GFG Supply, Inc. is denied.

Good morning.

GFG SUPPLY was the apparent low bidder on the referenced SOL, per the attached bid tabulation. However, the purchase will be awarded to 4th place, Taylor & Burns Coating, a South Carolina Resident Vendor. The difference in price is \$5,400.00.

I spoke in length to procurement officer, Candis Goldston, on Friday 5/24, trying to understand the application of Vendor Preferences to this commodity. I opened the link on page 15 of this Solicitation in the paragraph entitled "PREFERENCES-A NOTICE TO VENDORS"; then scrolled to "FREQUENTLY ASKED QUESTIONS FROM THE VENDOR'S PERSPECTIVE". On page 4 of those guidelines, in response to when preferences do not apply, it reads, "The preferences do not apply to acquisitions of motor vehicles.......or supplies or services relating to construction." Surely, these H PILES are used in construction. Note Attachment "A" included in the Solicitation (Section 709) "....contains specifications for........furnishing, fabricating and erecting steel structures...."

Candice explained to me that the exempt construction supplies mentioned above, refers to material purchased by a contractor doing work for the state of South Carolina, not supplies purchased by SC procurement. That explanation may be the intent of the clause, but it is not stated as such. To this vendor's perspective, I assumed that these construction supplies (H PILES) should be exempt from preference advantage and, thus, we participated accordingly.

On that reasoning, we hereby exercise our right to protest an award to any Vendor other than the lowest responsible bidder.

Protest Appeal Notice (Revised June 2018)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

FILING FEE: Pursuant to Proviso 111.1 of the 2018 General Appropriations Act, "[r]equests for administrative review before the South Carolina Procurement Review Panel shall be accompanied by a filing fee of two hundred and fifty dollars (\$250.00), payable to the SC Procurement Review Panel.
